SUMMARY:	The American Rescue Act Fund was approved by the City of Texarkana, Arkansas Board of Directors on December 20, 2021, with resolution 2021-65. This budget allocated \$972,090 in 2021 and the remaining \$656,637 in 2022. Of the total \$1,628,727, \$612,667.18 has been spent. The purpose of this agenda item is to approve the reimbursement of \$45,500 to the Texarkana Regional Airport for construction in connection with the Terminal Parking Lot. As this would be considered a general governmental service, it is eligible for reimbursement due to the City receiving less than \$10 million from the American Rescue Plan Act.
