### **RESOLUTION NO.**

### A RESOLUTION ADOPTING PREMIUM PAY FOR CERTAIN MUNICIPAL EMPLOYEES FROM THE AMERICAN RESCUE PLAN ACT

**WHEREAS**, the American Rescue Plan Act "ARPA", which was signed into law on March 11, 2021, provides fiscal relief funds to state and local governments and other program areas aimed at mitigating the continuing effects of the pandemic; and

**WHEREAS**, ARPA is intended to provide support to local governments in responding to the impact of COVID-19, and in their efforts to contain COVID-19, out of their communities, residents, and businesses; and

WHEREAS, ARPA provides stimulus grant funds permitting cities and towns the option to provide Premium Pay for eligible employees in order to provide additional support to those who have and will bear the greatest health risks because of their service in critical infrastructure sectors; and

WHEREAS, the United States Department of Treasury (hereinafter Treasury), has issued guidance and an Interim Final Rule (hereinafter IFR) regarding the use of ARPA funds; and

WHEREAS, Premium Pay is defined by the IFR as additional compensation for "eligible workers performing essential work during the COVID-19, public health emergency"; and

WHEREAS, the IFR provides that eligible workers are those "who have been and continue to be relied on to maintain continuity of operations of essential critical infrastructure sectors, including those who are critical to protecting the health and wellbeing of their communities"; and

WHEREAS, Treasury recognized essential critical infrastructure sectors as "healthcare, public health and safety, childcare, education, sanitation, transportation, food production and services" and also permits each city's chief executive to add additional sectors to the list if they are "deemed critical to protect the health and well-being of its residents"; and

WHEREAS, essential work involves regular in-person interactions or regular physical handling of items that were also handled by others; however, it does not include telework from a household; and

**WHEREAS**, the IFR emphasizes the need for recipients to prioritize Premium Pay for lower income workers most impacted by the pandemic; and

**NOW, THEREFORE, BE IT RESOLVED** by the by the Board of Directors of the City of Texarkana, Arkansas, that:

**Section 1.** The City of Texarkana, Arkansas, hereby appropriates a total amount up to \$400,000 to provide Premium Pay to eligible workers who meet the following ARPA eligibility criteria:

1) An eligible worker means workers necessary to maintain the continuity of operations of essential critical infrastructures

2) Including any additional sectors added by the city's chief executive as follows:

Administration staff, Finance staff, Court staff, Probation staff, City Clerk staff, Police officers and support staff, Fire fighters and support staff, Animal Care officers and support staff, Public Works staff, BiState Justice Center's maintenance staff, the Central Records and Communications manager, and Texarkana Water Utilities staff.

3) An eligible worker performing eligible work which means regular inperson interaction or regular physical handling of items that were handled by others.

Section 2. It is the intention of the City of Texarkana, Arkansas, to provide each full-time employee and part-time employee working more than 16 hours weekly retroactive Premium Pay in an amount not to exceed \$1,000 for eligible employees currently employed

by the City of Texarkana, Arkansas, and Texarkana Water Utilities that were hired before October 18, 2021;

**Section 3.** Retroactive Premium Pay in the amount of <u>\$6.25</u> per hour for hours not to exceed 160 hours worked as of October 18, 2021; and

**Section 4.** The City of Texarkana, Arkansas, appropriates the sum of \$25,000 to cover all applicable employer payroll contributions (FICA, Medicare, and the employer costs of APERS) for the Premium Pay from the Rescue Grant funds.

**Section 5.** The City of Texarkana, Arkansas, Board of Directors adopts, ratifies, and enacts Premium Pay from *Section 603* of the ARPA.

**Section 6.** Nothing in this resolution shall be construed as constituting an employment contract or as altering, modifying, or affecting the "at-will" employment relationship between the City of Texarkana, Arkansas, and any employee of the City of Texarkana, Arkansas.

## ORDINANCE NO.

AN **ORDINANCE** AUTHORIZING THE **ACOUISITION** OF POLICE **OFFICER** A TRAINING **STRUCTURE:** WAIVING ANY APPLICABLE COMPETITIVE BIDDING **PROVISION;** FOR DECLARING AN **EMERGENCY; AND FOR OTHER PURPOSES** 

**WHEREAS,** the Texarkana, Arkansas Police Department (TAPD) proposes that the City acquire a training structure for TAPD to train officers in entry training, shoot/don't shoot situations, force or force and simulated real-life call response techniques and skills; and

WHEREAS, a training structure manufactured by Simtek Modular (being Kit #4-STD) has been identified as the type and design of training structure sought by TAPD; and

**WHEREAS,** TAPD was unable to procure bids from any other source or supplier to provide the same product; and

**WHEREAS,** pursuant to Ark. Code Ann. §14-47-138, the Board of Directors may waive the requirements of competitive bidding in exceptional situations where competitive bidding is not feasible; and

**WHEREAS,** waiver of competitive bidding is also permitted by Section 2-72 of the *City of Texarkana, Arkansas, Code of Ordinances* for the reasons set out therein (one or more of which being applicable to the purchase contemplated hereby); and

WHEREAS, it is specifically recognized and determined by the Board of Directors, and as evidenced by the supporting documentation provided by TAPD in connection with its request for approval, that the training structure at issue is unique, specialized for the purpose of training police officers in the areas described above, and effectively offered by a single source in the specific design identified by TAPD for training needs; and

**WHEREAS,** to the extent the prior efforts undertaken by TAPD to acquire multiple competitive bids for a training structure do not satisfy any applicable competitive bidding

requirement, the approval of the purchase is being made by ordinance specifically recognizing such waiver as permitted by applicable law; and

**WHEREAS,** the purchase price for the above described SimTek Modular training structure is \$41,460.00; and

WHEREAS, the City Manager and TAPD staff request approval of the purchase, and, further, waiver of any applicable competitive bidding practices, all as and for the reasons described above;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Directors of the City of Texarkana, Arkansas, that:

**Section 1:** The purchase of Simtek Modular training structure (Kit #4-STD) in the amount of \$41,460.00, is approved and any competitive bidding practices that may be otherwise required by applicable law and ordinance are waived.

Section 2: The City Manager is authorized to enter into any agreement reasonably necessary carry out the purchase of said training structure on the terms and conditions hereby approved.

Section 3: This action being necessary for the preservation of the public peace, health and safety (including, without limitation, benefit of promptly making available the additional training resource for use by TAPD personnel for the better protection of the health and safety of TAPD personnel and the citizens of Texarkana), and a separate and distinct vote having been taken on this emergency clause, an emergency is therefore declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
