Mayor Allen Brown called the meeting to order at 1:03 PM.

PRESENT: Mayor Allen Brown, Ward 2 Director Laney J. Harris, Ward 5 Director Barbara S. Miner, and Ward 6 Director Terri Peavy.

ALSO PRESENT: City Attorney George Matteson, City Clerk/Assistant City Manager Heather Soyars and Deputy City Clerk Jenny Narens.

\*Assistant Mayor Ward 1 Linda Teeters attempted to join the meeting during the discussion of Item 6. Adopt an Ordinance levying the 2020 tax rate.

#### CONSENT

Director Harris requested the removal of Item 4. Adopt a Resolution authorizing the City Manager to purchase a TM 300-40 DHE Pothole Patcher for the Public Works Department Streets Division, from the Consent Agenda for discussion.

Director Harris made the motion to approve the Consent Agenda. Seconded by Director Peavy.

The motion carried unanimously.

The items approved were:

- 1. Approval of the minutes of the regular rescheduled meeting August 3, 2020. (CCD)
- 2. Resolution No. 2020-25 authorized the City Manager to enter into a construction contract with Tatum Excavating Company, Inc., (TEC) for East 18th Street, East 50th Street and Sanderson Lane Rehabilitation. (PWD)
- 3. Resolution No. 2020-26 authorized the City Manager to purchase a Kubota Tractor for the Public Works Department Streets Division. (PWD)

#### REGULAR

4. Resolution No. 2020-27 - authorized the City Manager to purchase a TM 300-40 DHE Pothole Patcher for the Public Works Department Streets Division. (PWD)

Director Harris said he was excited about the equipment being purchased and it would help the road crew throughout the whole City.

5. Consider the following action concerning the 2020 Byrne Justice Assistance Grant Program:

Conduct a Public Hearing to allow citizen input regarding the use of Byrne Justice Assistance Grant Program monies for the Texarkana, Arkansas Police Department.

Mayor Brown opened the Public Hearing.

Lieutenant Nick Elrod said the Police Department received money through the DOJ Edward Byrne Justice Assistance Program each year and request permission to submit the joint 2020 application and enter into an Inter-local Agreement with Miller County concerning the division of funds in the amount of \$15,251.00. Miller County would receive \$5,083.00 and the Police Department would receive \$10,168.00.

Director Peavy asked how the grant money would be spent.

Lieutenant Nick Elrod said the money would be used towards the purchase of two Watchguard Video Systems.

No one else came forward and Mayor Brown closed the Public Hearing.

Resolution No. 2020-28 - granted permission to submit the 2020 application and further authorized the City Manager to execute a Memorandum of Understanding (MOU) Interlocal Agreement with Miller County, regarding the Byrne Justice Assistance Grant (JAG-yearly grant).

Director Peavy made the motion to adopt the resolution, Seconded by Director Miner.

The motion carried 4-0. The Mayor declared the resolution adopted.

	On Tuesday August 4 <sup>th</sup> , 2020 a bid opening was conducted at City Hall for the referenced project. Two qualified bids were received that met the bidding requirements. A.L. Franks Engineering reviewed the bids and found no errors in the submission. The low bid by TEC, Inc. is \$143,936.55 over the budget amount of \$313,358.00.			
	To cover the overage for this project city staff has received an additional donation of \$71,061.55 from Partnership for the Pathway and the Public Works Director will make a change order to the project in the amount of \$72,875.00 for City Street Division in-Kind labor/materials match for ROW prep and installation of existing city bridge on the EDP Sports Complex section of the trail. The two bids submitted are summarized below:

Dear Dr. Haskin:

On Tuesday August 4<sup>th</sup>, 2020 a bid opening was conducted at City Hall for the referenced project. Two qualified bids were received that met the bidding requirements. We have reviewed the bids and found each submittal to be an acceptable bid from a qualified contractor. A bid tabulation is further provided of the three low bids and summarized below:

TEC, Inc.	\$457,294.55
Francis Excavating	\$495,577.39

The low bidder is TEC, Inc. from Texarkana, Texas. TEC is licensed in the State of Arkansas. TEC, Inc. is very experienced and capable to complete the project. We recommend award of the trail project (contingent upon ARDOT approval) to TEC, Inc. in the amount of four hundred fifty-seven thousand, two hundred ninety-four dollars and fifty-five cents (\$457,294.55).

The scope of the project include trail construction along Nix Creek that will connect and extend the existing trail network. Additional trails are also proposed near the existing City Park / Complex along Roberts Street. A pedestrian bridge is also included near the existing Boys & Girls Club that is currently considered for improvements.

This project is largely funded through ARDOT through the RTP program and does require local matching funds. The award from ARDOT included a total grant amount of \$295,500.00 (80% grant). To receive the full amount from ARDOT the City is required to provide 20% matching funds or a combination of in-kind labor to a value of \$73,875.00. These combined amounts bring the budget for the project to a total of \$369,375.00. Additional funding by local sources can also be utilized to complete the entire scope of the project.

Therefore, we further recommend a forthcoming change order with TEC, Inc. to address these items.



On behalf of the Partnership for the Pathway, we are pleased to inform you that the Partnership Board of Directors has agreed to fund the additional \$71,061.55 needed to cover the shortfall incurred in completing the four following recreational trail projects. The four projects include: Nix Creek – Jackson Street Trail, Ermer Dansby Pondexter Sports Complex Trail Connection, Siebert Street Trail, and Park Trail Connections

In addition, the Partnership for the Pathway is continuing to honor our 2015 pledge to provide additional funds of \$14,443.81 for the Jackson Street Trail and Bridge recreational trail project.

This come to total funding of \$85,505.36. Payments will be made to the City of Texarkana, Arkansas as we receive periodic invoices documenting progress on the above projects.

SUMMARY:	TAFD has received a Federal grant in the amount of \$143,500 to install vehicle exhaust removal systems at our fire stations. This grant requires a 10% local match or \$14,350. Additionally, our College Hill station was constructed too recently to qualify for this grant. The cost to include this station is \$34,850. We would also like to request \$5,000 in contingency funds for this project. A limited amount of companies manufacture these systems so we were only able to get two bids.


