Changes in Net Position – Governmental Activities






Revenue – Governmental Activities






2018 Governmental Activities Revenue by Source






Expenses – Governmental Activities

Number of Days Expenditures in General Fund Unrestricted Fund Balance

The adequacy of unassigned fund balance in the general fund should be assessed based upon a government's own specific circumstances.

Nevertheless, GFOA recommends, at a minimum, that general-purpose governments, regardless of size, maintain unassigned fund balance in their general fund of no less than two months (or 60 days) of regular general fund operating revenues or regular general fund operating expenditures

Mayor Allen Brown called the meeting to order.

PRESENT: Mayor Allen Brown, Ward 1 Assistant Mayor Linda Teeters, Ward 2 Director Laney J. Harris, Ward 3 Director Steven Hollibush, Ward 4 Director Travis Odom, Ward 5 Director Barbara S. Miner, and Ward 6 Director Terri Peavy.

ALSO PRESENT: City Manager Dr. Kenny Haskin, City Attorney George Matteson, and City Clerk Heather Soyars.

ABSENT: Deputy City Clerk Jenny Narens.

Invocation and Pledge of Allegiance given by Director Terri Peavy

PRESENTATION(S)

1. Mayor Brown presented a proclamation to TWU-IT Manager Kevin Davenport for IT Professionals Day, September 17, 2019.

[Director Odom left his seat at the dais and went into the audience at 6:03 PM.]

CONSENT

Director Harris requested Item 3. Adopt a Resolution to amend the year end 2019 Budget to include a 2% pay increase for all City employees. (FIN) to be removed from the Consent Agenda for discussion.

Motion to approve the Consent Agenda made by Director Hollibush, Seconded by Director Miner.

The motion carried unanimously, and Mayor Brown declared the Consent Agenda approved. The items approved was:

2. Approval of the minutes of the rescheduled regular meeting September 3, 2019. (CCD)

REGULAR

[Director Odom returned to his seat at 6:10 PM]

3. Resolution No. 2019-33 amended the year end 2019 Budget to include a 2% pay increase for all City employees. (FIN)

Director Harris said he was glad all City employees were going to receive a pay increase.

Motion to adopt the resolution made by Director Harris, Seconded by Director Hollibush.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Harris, Director Hollibush, Director Odom, Director Miner and Director Peavy.

Mayor Brown declared the resolution adopted by a 7-0 vote

4. The Mayor opened the Public Hearing to hear public comments regarding the condemnation of a substandard residential structure located at 307 Charles Street.

Building Official Shawn Maxey said the structure at 307 Charles Street had a fire and was destroyed and now the City was maintaining the property. He was asking the Board to condemn the residence.

Director Harris said behind the property was a dumping ground and asked how the City was going to handle this situation.

Building Official Shawn Maxey said unless the City caught the person in the process of dumping trash or someone told the City who was doing it, there was nothing the City could do.

Director Harris asked when the two houses were going to be torn down.

Building Official Shawn Maxey said the houses were scheduled right now to be torn down.

Director Harris asked when the house that was burned down on the corner of Dudley and Cleveland, and another house on Spring Street and Grape Street was going to be brought before the Board for condemnation.

Building Official Shawn Maxey said he had one hundred and fifty tagged structures and thirty five were burned. He said he would bring them before the Board around the first of the year for condemnation.

Director Miner asked if the person dumping trash on the property had anything to do with the homeowners.

Building Official Shawn Maxey said he had been told it was the son of the property owners.

Mayor Brown asked if anyone had any comments. No one came forward and the Mayor closed the Public Hearing.

Resolution No. 2019-34 condemned a residential structure located at 307 Charles Street. (PWD)

Motion to adopt the resolution made by Director Hollibush, Seconded by Director Harris.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Harris, Director Hollibush, Director Odom, Director Miner and Director Peavy.

Mayor Brown declared the resolution adopted by a 7-0 vote.

5. Mayor Brown opened the Public Hearing to hear public comments concerning the Community Development Block Grant (CDBG) Section 108 Loan in the amount of \$885,000 to rehabilitate #1 Legion Drive to provide youth, adult and senior recreational services to our citizens. (PWD)

Jim Fowler, Rose Law Firm said this was a Housing and Urban Development (HUD) program to extend money to local governments. It allowed them to borrow money at the rate the Federal government did. He said there were issues with the standard HUD forms, but he and Assistant Public Works Director Tracie Lee had been able to negotiate and approve better documents for the City. Jim Fowler said he had not received the documents yet and would like to table the ordinance until the next meeting and hopefully he would have the documents.

Motion to table the ordinance until the next meeting, motion made by Assistant Mayor Teeters, Seconded by Director Peavy.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Hollibush, Director Miner and Director Peavy.

Director Harris voted present.

Director Odom refrained from voting.

Mayor Brown declared the ordinance was tabled by a 5-2 vote.

6. TABLED - Adopt an Ordinance to establish an Entertainment District that allowed open containers of alcohol and consumption in the district. (SECOND READING) (*This item recommended for Board approval by the Planning Commission*) (PWD-Planning)

Mayor Brown recommended tabling the original ordinance due to several changes that were made and read for the first time the new ordinance. He said he had been contacted by several citizens and they would like this ordinance to be passed tonight if possible.

City Planner Mary Beck listed some of the changes made to the ordinance: State Statute stating there would be no open containers allowed in motorized vehicles; a licensee may allow carryout of an open container in the entertainment district but no one would be able to carry an open container into a business establishment; the City was to provide trash cans and daily pick up as needed; there would be a review in June 2020 and January 2021 the Planning Commission would gather information from the Public Works Department, Fire Department, and the Police Department and bring a report to the Board.

Director Miner asked if issues were to arise, who would be the ruling party.

City Planner Mary Beck said the Board would be after the Planning Commission prepared the report.

City Manager Dr. Kenny Haskin said in the event there needed to be action taken, the Board would be able to take immediate action to address issues.

Director Peavy asked if issues arose would the Board have to wait six months before anything would be done.

City Planner Mary Beck said no.

City Manager Dr. Kenny Haskin said if there were any concerns from citizens, Board members or businesses, it would be addressed promptly. The City would not wait six months to address any issues.

Director Miner said she thought it would need to be monitored closely at first.

Mayor Brown said once the ordinance had been adopted then the Board had the option to change and review anything. He said he accepted the changes and the one statement he would add would be the district would be reviewed annually after January 2021.

Director Peavy asked if it could say reviewed as needed.

Director Harris said he had citizens ask him a few years ago if Texarkana, Arkansas, could get a street like Beale Street in Memphis and he thought it was against the law at that present time. He said another citizen asked him about getting a daiquiri shop and he was not sure if the law allowed it.

Mayor Brown said the State Legislative adopted the law that allowed the entertainment district this past session.

City Attorney George Matteson said the Alcohol Beverage Control (ABC), in Little Rock, Arkansas, was the one who regulated the sale and distribution of alcohol. If that type of business would fit in the zoning regulations yes, you could have that type of business.

Director Harris said he had not had anyone from his ward ask him to deny this ordinance.

Assistant Mayor Teeters asked if a business wanted to be open and sell alcohol on Sunday it would be up to the business.

City Attorney George Matteson said again it was governed by the state and most of the businesses were private clubs.

Assistant Mayor Teeters said if the City had a festival downtown on a Sunday and the business had the permit, liquor could be sold.

City Attorney George Matteson said yes.

Assistant Mayor Teeters said you could not walk into another business that did not have the permits.

Director Peavy asked who granted permits for Sunday sells of alcohol.

Mayor Brown said ABC would.

Director Peavy asked if the signs and trash cans would be ready to go within the thirty days of the ordinance being adopted.

Public Works Director Tyler Richards said yes.

Motion to table the original ordinance made by Assistant Mayor Teeters, Seconded by Director Hollibush.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Hollibush, Director Harris, Director Odom, Director Miner and Director Peavy.

Mayor declared the original ordinance tabled by a vote of 7-0.

Ordinance No. 20-2019 established an Entertainment District that allowed open containers of alcohol and consumption in the district. (*This item recommended for Board approval by the Planning Commission*) (PWD-Planning)

The ordinance was read in its entirety.

Motion to suspend the rules and place the ordinance on its second reading in abbreviated form made by Director Hollibush, Seconded by Assistant Mayor Teeters.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Harris, Director Hollibush, Director Odom, Director Miner and Director Peavy.

The motion carried 7-0. The ordinance was read the second time in abbreviated form.

Motion to further suspend the rules and place the ordinance on its third and final reading in abbreviated form made by Director Harris, Seconded by Director Hollibush.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Harris, Director Hollibush, Director Odom, Director Miner and Director Peavy.

The motion carried 7-0. The ordinance was read the third and final time in abbreviated form.

Motion to adopt the ordinance made by Director Hollibush, Seconded by Director Harris.

Voting Yea: Mayor Brown, Assistant Mayor Teeters, Director Harris, Director Hollibush, Director Odom, Director Miner and Director Peavy.

The motion carried 7-0. The Mayor declared the ordinance adopted.

Director Peavy asked what the fifty mile radius was from the previous meeting regarding competitive pay.

City Manager Dr. Kenny Haskin said the fifty mile radius was not part of the ordinance that was adopted, the City addressed the region, not the fifty mile radius.

Director Harris asked when the Iron Mountain Center would be cleaned up. He asked when the entire City would have a clean up to remove all the dumped furniture on the sides of streets.

Public Works Director Tyler Richards said his department picked up furniture every day and it was impossible to get it all. He said as people complain, Public Works immediately got it picked up.

Director Harris asked if the residents got charged for the pickup of furniture due to the ordinance that was adopted.

Public Works Director Tyler Richards said if a resident set any furniture out on their curb to pick up, they would be charged for it through the Dial A Truck program.

Director Harris asked when the City wide cleanup was.

Public Works Director Tyler Richards said the City did not organize the city wide cleanup.

Director Harris said he thought the City needed to have a cleanup since there was a lot of trash and furniture especially around the railroad tracks.

Mayor Brown said maybe the City could address this in the budgeting process and could allocate funds for a cleanup.

Assistant Mayor Teeters said the trash issue was a problem with the citizens not the City officials. She said Public Works could go out and pick up the trash every day and it would be back the next day.

Director Harris said he just wanted each ward to help in the cleanup of the City.

CITIZEN COMMUNICATION

Ina McDowell, Mainstreet, thanked the Board for the continued support of the downtown area as well as Mainstreet. She said Dine on the Line was October 4, 2019, from 5:00 PM – 9:00 PM. Ms. McDowell said the theme was "date night," and dinner would be served this year instead of standing in line for it. She said there would be plenty of local entertainment and the unveiling of the Dr. Pepper mural next to TLC. Ms. McDowell said Mainstreet would have design staff in town next Tuesday from Little Rock, Arkansas.

Mayor Brown said he was scared to death this past weekend going "Over the Edge" for Alzheimer but once he realized the rope had him, it was better. He said it was for a great cause and he would let Assistant Mayor Teeters do it next year.

George Dodson, Hopkins Icehouse, thanked the Board for adopting the ordinance for the entertainment district and the confidence the Board had in the businesses downtown. He said if there were any problems or anything he could help with, please come and find him.

Animal Care and Adoption Center Director Charles Lokey said he wanted to give an update on the plans for the new shelter. He said last month he sent out proposals for architectural services and received two proposals back. Mr. Lokey said one proposal left out some major details and the other proposal covered everything from beginning to the end and offered to oversee the construction process and biddings.

PURCHASE AND SALE AGREEMENT

THIS PURCHASE AND SALE AGREEMENT (this "Agreement") is entered into by and between Vessel Church, Inc., a Texas corporation (hereinafter referred to as "Seller"), and, the City of Texarkana, Arkansas (hereinafter referred to as "Buyer").

1. **Property.** Seller will sell and Buyer will buy the property described as follows (collectively, the "Property"):

The East 13.65 feet of Lot Numbered Eight (8) in Block Numbered Seventy-five (75) of the ORIGINAL CITY of Texarkana, Miller County, Arkansas,

along with any and all appurtenances, easements, improvements, fixtures, appliances and mechanical aspects thereof.







Arkansas FY19 to FY19 Revised Expenditures



AN ORDINANCE TO AMEND ORDINANCE K-286, CHAPTER 28, ARTICLE III, SEC. 28-22; & SEC. 28-23, TO ADD MOBILE FOOD VEHICLES ALSO KNOWN AS FOOD TRUCKS AS A LAND USE IN VARIOUS ZONES; AND ARTICLE XI, SEC. 28-142 DEFINITIONS RELATED TO MOBILE FOOD VENDORS

WHEREAS, the City desires to provide opportunities for increased business activities to support cultural and art events; and to provide opportunities for increased business activities to serve food to the public at large; and

WHEREAS, the Planning Commission does recommend incorporating applicable regulations for permitting and operations on private property to follow regulations stated in Chapter 13 of the *City of Texarkana*, *Arkansas*, *Code of Ordinances*; with the addition to Chapter 28, the zoning chapter, such definitions that are applicable to privately owned land; namely amendments to:

ARTICLE XI, SEC. 28-142 definitions related to Mobile Food Vehicles aka food trucks:

- Food trucks. A type of mobile food vehicle which is motorized, and operationally self-contained equipped with enclosed facilities for cooking, preparing, and selling prepared food and/or beverages and does not include ice cream trucks or other types of food delivery trucks operating under a hawker's license selling door to door.
- Food trailers. A type of mobile food vehicle which is designed to be towed on public roads equipped with enclosed, self-contained, facilities for cooking, preparing, and selling prepared food and/or beverages.
- *Commissary*. A location designated by the city at which a mobile food vendor holding a valid mobile food permit pursuant to this chapter may dispose of wastewater from storage tanks and/or clean any utensils or kitchenware associated with mobile vendor's operations under this chapter.

- *Mobile food vendor*. A person or entity holding a mobile food vendor permit in accordance with regulations stated in Chapter 13.
- *Mobile food vendor permit.* A permit issued to a mobile food vendor pursuant to Chapter 13.
- *Ice Cream Trucks*. A traditional type of motorized vehicles operating for the sole purpose of selling ice cream, frozen dessert-type snacks, snow cones and popsicles; not to include sales of any other food types or products, subject to Article II, Sec. 13 (37-41), otherwise known as a hawkers license.
- *General pushcarts*. A wagon-type, non-motorized vending vehicle subject to Article II, Sec. 13 (37-41), otherwise known as a hawkers license.

WHEREAS, suitable zoning districts in Article III, Sec. 28-22 and Sec. 28-23, that is, all industrial and commercial zones except O-1 Office commercial. Notes: Customer parking needs will be determined by the building official at the time permits are issued in order that business be conducted in an orderly manner without negative impact to adjacent land uses;

NOW THEREFORE, BE IT ORDAINED by the Board of Directors of the City of Texarkana, Arkansas, these regulations are hereby adopted and incorporated into the City of Texarkana, Arkansas, Code of Ordinances.

the municipal code.

COMPATIBILITY WITH EXISTING DEVELOPMENT:

Commercial sale of foods is an important economic generator and is a land use currently approved in all commercial zones other than O-1 Office quiet; and, can be a suitable land use in areas of industrialization and with that suitability, portable availability of food choices is seen as a benefit for many such as workers in manufacturing areas, business people with short lunch hours, participants at public events, family outings, visitors to the city, etc.

Process:

Request received from City Board of Directors, citizen, developer, company, or initiated by the staff – Requests for a zoning ordinance text amendment can be made at any time. These requests may be initiated by the City Board of Directors, a citizen, a commercial developer, a company, or the staff itself. Many times, these requests are the result of new land uses, changes in residential housing types or densities, omissions in the original zoning ordinance, etc.

Staff Research - Research and development of draft regulations;

Staff Recommendation - Planning Division staff researches and makes a staff recommendation to Planning Commission;

Legal Notice – Publish legal notice in the Texarkana Gazette one time fifteen days prior to the public hearing;

Public Hearing – The Planning Division staff presents staff



recommendation to Planning Commission during required public hearing;

Planning Commission – Makes one of the following determinations:

- Reject the staff recommendation and request further study/analysis;
- Recommend denial of the Zoning Ordinance text amendment:
- 3. Recommend approval of the Zoning Ordinance text amendment;

City Board of Directors – If recommended for approval by the Planning Commission, the City Board of Directors considers adopting an ordinance enacting/accepting the Zoning Ordinance text amendment. The proposal could also be heard by the City Board of Directors if the Planning Commission's recommendation of denial was appealed to the City Board of Directors. The City Board of Directors makes one of the following determinations:

- 1. Reject the Planning Commission's recommendation and request further study/analysis;
- 2. Recommend denial of the Planning Commission's Zoning Ordinance text amendment(s);
- 3. Recommend approval of the Planning Commission's Zoning Ordinance text amendment(s);

Ordinance – Becomes effective in thirty (30) days or with adoption of an emergency clause as part of the ordinance, the ordinance would become effective immediately; and

City Clerk - Following adoption by the legislative body, the adopted plans, ordinances, and regulations shall be filed in the office of the city clerk.

CONFORMANCE WITH APPLICABLE ORDINANCES AND/OR STATE STATUTES:

The Arkansas Code of 1987 Annotated (14-56-422 1B) requires the following - "All plans, recommended ordinances, and regulations shall be adopted through the following procedure for adoption of plans and regulations:

- (1) (A) The Planning Commission shall hold a public hearing on the plans, ordinances, and regulations proposed under this subchapter.
 - (B) Notice of public hearing shall be published newspaper of general circulation in the city, at least one (1) time fifteen (15) days prior to the hearing.
- (2) Following the public hearing, proposed plans may be adopted, and proposed ordinances and regulations may be recommended as presented, or in modified form, by a majority vote of the entire commission.



- (3) Following its adoption of plans and recommendation of ordinances and regulations, the commission shall certify adopted plans or recommended ordinances and regulations to the legislative body of the city for its adoption.
- (4) The legislative body of the city may return the plans and recommended ordinances and regulations to the commission for further study or rectification, or, by a majority vote of the entire membership, may, by ordinance or resolution, adopt the plans and recommended ordinances or regulations submitted by the commission. However, nothing in this subchapter shall be construed to limit the city board's authority to recall the ordinances and resolutions by a vote of a majority of the council.
- (5) Following adoption by the legislative body, the adopted plans, ordinances, and regulations shall be filed in the office of the City Clerk. The City Clerk shall file, with the county recorder of the counties in which territorial jurisdiction is being exercised such plans, ordinances, and regulations as pertain to the territory beyond the corporate limits.

The required statutory notice was published fifteen (15) days prior to the public hearing as required by the *Arkansas Code of 1987 Annotated 14-56-422* (Adoption/amendment of plans, ordinances, & regulations) on Sunday, August 25, 2019 for the September meeting.

OPPOSITION TO ZONING ORDINANCE TEXT AMENDMENT:

No opposition has been received.

Support has been indicated in other venues from local business owners including DeAnna O'Malley, George Dodson, and other downtown business owners and had no opposition from the Commission.

ADDITIONAL ACTION BY CITY BOARD OF DIRECTORS:

The City Board of Directors could review the Planning Commission's recommendation at their regularly scheduled meeting and may adopt, amend, return, or deny the request. It is anticipated the Board will consider the ordinance at the regularly scheduled October 7, 2019 meeting.

PLANNING COMMISSION RECOMMENDATION:

To amend the Texarkana Municipal Code, Ordinance K-286, zoning



regarding Chapter 28, Article III, Sec. 28-22 & 23 to recommend addition of food trucks as defined below as an allowed land use in all commercial and industrial zones except O-1 Office quiet.

Adopt the definitions from Chapter 13 of the *Municipal Code* of the City of Texarkana, Arkansas; to be included in Chapter 28, the zoning chapter, such definitions that are applicable.

COMPATIBILITY WITH EXISTING DEVELOPMENT:

The site consists of a commercial metal building that has been vacant for several years. It is not suitable for a residence without alteration. The previous use of the building operated under a conditional use permit for a square dance club that was called Guys and Dolls and functioned as a community building. Since closing, the land and building were deeded to the Animal League for use as an asset to their cause. Many animal related land uses would be problematic to the adjacent fire station and the building is under contract for sale for a quieter land use as an office to do billing. Office activities are very appropriate in residential zones and near fire stations.

Current zoning:

R-2 single-family residential zoning district is defined as follows:

This is the most restrictive urban residential district. The principal use of land is for detached single-family dwellings and related recreational, religious, and educational facilities normally required to provide the basic elements of a balanced and attractive residential area. These areas are intended to be defined and protected from the encroachment of uses not performing a function necessary to the residential environment. Internal stability, attractiveness, order and efficiency are encouraged by providing for adequate light, air and open space for dwellings and related facilities and through consideration of the proper functional relationship of each element.

Proposed zoning:



O-1 office and guiet business district is defined as follows:

This district is established to accommodate offices and associated administrative, executive and professional uses, together with specified limited commercial and accessory uses. It is anticipated these office uses will be located in relatively close proximity to apartments and other residential uses; and area regulations are designated to assure that these uses will be compatible with adjacent residential district. The district is characterized by freestanding buildings and ancillary parking, and should generally be limited to arterial and collector street locations or other carefully selected areas where public utilities, community facilities and other public services are adequate to support general office and limited commercial development.

The 1988 Long term comprehensive plan shows this area recommended for single family residential. O-1 Office is appropriate for all residential zones as the nature of office practices has low traffic counts and low noise land uses.

CONFORMANCE WITH APPLICABLE ORDINANCES AND/OR STATE STATUTES:

The Arkansas Code of 1987 Annotated (14-56-422 1B) requires the following - "All plans, recommended ordinances, and regulations shall be adopted through the following procedure for adoption of plans and regulations:

- (1) (A) The Planning Commission shall hold a public hearing on the plans, ordinances, and regulations proposed under this subchapter.
 - (B) Notice of public hearing shall be published newspaper of general circulation in the city, at least one (1) time fifteen (15) days prior to the hearing.
- (2) Following the public hearing, proposed plans may be adopted, and proposed ordinances and regulations may be recommended as presented, or in modified form, by a majority vote of the entire commission.
- (3) Following its adoption of plans and recommendation of ordinances and regulations, the commission shall certify adopted plans or recommended ordinances and regulations to the legislative body of the city for its adoption.
- (4) The legislative body of the city may return the plans and recommended ordinances and regulations to the commission for further study or rectification, or, by a majority vote of the entire membership, may, by ordinance or resolution, adopt the plans and recommended ordinances or regulations submitted by the commission. However, nothing in this subchapter shall



be construed to limit the city board's authority to recall the ordinances and resolutions by a vote of a majority of the council.

(5) Following adoption by the legislative body, the adopted plans, ordinances, and regulations shall be filed in the office of the City Clerk. The City Clerk shall file, with the county recorder of the counties in which territorial jurisdiction is being exercised such plans, ordinances, and regulations as pertain to the territory beyond the corporate limits.

The required notice was published in the Sunday, July 28, 2019 edition of the *Texarkana Gazette*. The City notified nine (9) adjacent property owners within three hundred feet (300') as required by the *Texarkana*, *Arkansas Code of Ordinances*.
