NEW BUSINESS:

Brendan & Kathleen Weiden, 7 Erie Ave, Narrowsburg, NY 12764 Application for Healthy Kids Program / Day Care Center SBL 9-10-12

Sullivan County Community College has a Healthy Kids Day Care Program. There are 68 Healthy Kids Day Cares across New York State.

Room 113 and 114 will be converted into the day care. These were previously kindergarten classrooms. Applicant will be taking out windows and replacing them with doors. Other minor modifications in the classrooms for before and after school kids.

Applicant read a letter from Sullivan County Community College President in regards to the Healthy Kids Program.

The projected number of kids is the toddler room is a max of 10 kids, and the preschooler room has a max up to 14 kids. This will be for before and after school kids.

Brad Grant, Engineer

Are the classrooms currently occupied? Yes they are

Outside play areas? Just little Tike stuff will be there that can be brought in after use and put out the next day. These will be on the grass area.

The stone patio that is there is a walkway to the new door.

Touch up painting will be done around the new doors. The carpet will be ripped up for more solid surface and easy to clean. Use caution with the concrete floor watching for moisture. The hot air overhead existing ventilation will be used. The bathrooms in each classroom already have the small toilets in them and if handicapped bars need to be installed this will be done.

Brad recommends having a walk thru with the Code Enforcement Officer. Mini splits will be installed for Air Conditioning.

Concerns about the fence. The fence will be at the edge of the parking lot where the kids are. The fence would be a split rail fence with a wire mesh backer. Wheel stops will be reinstalled. It is not anticipated to have the play area totally fenced in. There is no NYS requirement. The board is concerned that there should be totally enclosed so no kid walks off.

Other board concerns: Is there video cameras? Yes there are already cameras Do the doors lock so no one walks in? Alarms on exit doors? Intruder? Lock Down? Yes the doors lock from the inside and have ability for lock down.
