Steve Dweck is present who will be operating the day care center and handed out brochures. The Weidens will be adding key activation doors, scissors gate, exterior fence, along with three interior cameras and three outside cameras.

Iris – this is a great and necessary project

Public hearing closed at 7:12 PM. Mary returned

The public hearing opened at 7:12 PM for Laura Santana, 90 Main Street, Narrowsburg, NY SBL 9-10-12. This is for mercantile and Big Eddy Brewing.

Carl Wasser is excited for this project and has been in contact with the water and sewer department. There are two tanks there and looking at new water hookup.

This was submitted as two separate applications and reviewing as one for approval. The Code Enforcement Officer has reviewed the plans. There are different uses in the building and if the uses change, the applicant will need to come back to the board.

Amy Yoes concerns: 1- outside loud music and 2- outside lighting issue There are no plans for outside dining or music. Outside lighting can not leave the property. There are no plans for the driveway area /outside eating. The applicant has to follow the town guidelines on noise ordinance. The applicant will meet with Amy Yoes, neighbor.

Board member, Mary brought up concerns about parking. Per the current zoning, shared parking is not allowed in the zoning. Reviewing the comprehensive plan there is a shortage of parking. What about other parking if the other businesses say no such as the feed mill, and lumber company, we do have parking behind the bank.

There is a parking committee that is reviewing this concern.

Town Clerk, Crystal Weston pointed out that many business owners on main street are also parking on main street. The business owners should park up behind the bank. When the funeral home was conducting a funeral, people parked on main street, and down by Lake Erie.

Peg Harrison, who previously owned the funeral home that they were allotted 110 people and there would be 50-75 cars on main street. Business owners always accepted when there was a funeral.

Jim Crowley stated that all of down town does not comply with parking and businesses / occupancy rates. All the businesses would be shut down as none of them comply. Parking has to be figured out.

Steve Stuart- parking will defeat or promote growth. In Woodstock NY, which is similar to Narrowsburg Main Street, they run a shuttle bus back and forth. Also, support the Santana's with the building renovations.

Ed – possible to shuttle people

Stephen Gregoretti, SVG 17, 8 Main Street, Narrowsburg, NY SBL 10-1-2

Janine Hector is present representing Stephen Gregoretti. The project is located behind main street along the fire lane. This was going to be a garage and to shore up the foundation. This request is to turn into office spaces for a real estate. The only access to the entrance is from going under the bridge. This was an addition off the building and the board cannot accept the application. A site plan is needed from an engineer. This application has been tabled until all documents are received.

This was built with no permit.

Ed – this is accessible on the fire lane behind the building which is fire lane access only.

How will they be able to operate? This is not accessible from main street and you would need to walk around. Due to not being able to fit more than 49 people in it, does not need a second access and there are plenty of window.

Board comments:

John asked if you can access a building from a fire lane, is this allowed? There is nothing in the code either way. You cannot turn a vehicle around back there. The propane/fuel tanks are either buried or there is one as a community tank with meters.

Dawn from Eagle Valley Reality stated that the proposed real estate office needs to have an associate broker. The applicant mentioned has an office in Barryville.

The town board has to accept Sean Harringtons resignation before a new member can be appointed. With Seans resignation, there is a possible applicant from Lava area. Brian Mendoza is interested in the open board position.

Public Comment

Steve Stuart stated that the planning board was not made aware about this commercial space at 8 Main Street and that nothing was presented to the planning board.

Jim Crowley – the Code Enforcement Officer was notified that the work was being done by neighbors during covid. No building permits have been issued and this has to go through the planning board. It has been occupied illegally.

The next board meeting will be on May 24. Ken Baim has grievance day in the town office on this date from 2-4 PM and 6-8 PM, he will not be at the meeting.

The Code Enforcement Officer has brought other items to the board that the board has made recommendation to table this.
