## 2.4 Set a Public Hearing: Local Law2 of 2020 to Amend Chapter 115 of the Town Code Entitled Animals

#### TOWN OF TUSTEN LOCAL LAW NO. 2 OF 2020

## A LOCAL LAW TO AMEND CHAPTER 115 OF THE TOWN CODE ENTITLED ANIMALS

Be it enacted by the Town Board of the Town of Tusten, County of Sullivan, State of New York, as follows:

#### Section 1. Title and Applicability

This Local Law shall be referred to as a "Local Law Amending Chapter 115 of the Town Code."

#### Section 2. Purpose and Intent

The Town Board of the Town of Tusten has determined that dog excrement that is not dosposed of by the dog's owner presents a safety and public health hazard to the residents and visitors to the Town and that a penalty shall be imposed for dog owners who do not remove and properly dispose of their pet's feces. The Town Board has also determined that the owner of any dog that is seized pursuant to section 115-6 of the Town Code shall pay an impoundment fee to redeem the dog.

Chapter 115 of the Town of Tusten Town Code entitled "Animals" is hereby amended as follows:

Section 115-5 entitled "Restrictions" shall be deleted and replaced with the following:

#### § 115-5. Restrictions and Requirements.

- A. It shall be unlawful for any owner of any dog in the Town to permit or allow such dog to:
  - (1) Run at large unless the dog is restrained by an adequate leash or unless it is accompanied by its owner or a responsible person and under the full control of such owner or person on private property, with consent of the property owner or licensee. For the purpose of this article, a dog or dogs hunting in the company of a hunter or hunters shall be considered as accompanied by their owner.
  - (2) Engage in habitual loud howling, barking, crying or whining or conduct itself in such a manner so as to unreasonably and habitually disturb the comfort or repose of any person other than the owner of such dog.
  - (3) Uproot, dig, or otherwise damage any vegetables, lawns, flowers, garden beds, or other property without the consent or approval of the owner thereof.
  - (4) Chase, jump upon or at or otherwise harass any person in such a manner as to reasonably cause intimidation or fear or to put such person in reasonable apprehension of bodily harm or injury.

- (5) Habitually chase, run alongside of or bark at motor vehicles, motorcycles or bicycles while on a public street, highway or place, or upon private property without the consent or approval of the owner of such property.
- (6) Create a nuisance by defecating, urinating or digging on public property, or on private property without the consent or approval of the owner of such property.
- (7) If a female dog when in heat, be off the owner's premises unrestrained by a leash.
- B. The owner(s) of any dog in the Town shall comply with the following:
  - Any person who owns or controls a dog must immediately remove any feces left by that dog on any sidewalk, gutter, street, or other public area and dispose of it in a sanitary method.
  - (2) Any person who owns or controls a dog must immediately remove any feces left by that dog on any private property, when the property owner has not given consent for the feces to remain on the property.
  - (3) The foregoing subparagraphs (1) and (2) shall not apply to a guide dog accompanying any blind person.

Section 115-6, entitled "Seizure of dogs" is amended to insert the following new subparagraphs:

- D. The owner of any dog that is seized may redeem the dog within five days of the seizure of the dog by paying to the Town Clerk the impoundment fee set by the Town Board and presenting the receipt for payment of the fee to the shelter that is harboring the dog.
- E. Any dog that is not redeemed within five days shall forfeit all title to the dog and the dog shall than be made available for adoption at the discretion of the shelter.

Section 115-7 entitled Penalties for offenses shall be amended as follows:

Subparagraph B(1) shall be replaced to read:

(1) First offense: no more than \$100.

By inserting a new subparagraph C as follows:

C. Creating a nuisance by failing to remove feces per subsection 115-5(B)(1) and 115-5(B)(2)

Subparagraph C shall be re-lettered to be subparagraph D.

Section 115-10 entitled "Licensing requirements and procedures" shall be amended by adding the follow sentence to the end of subparagraph (A)(5)(a):

The Town Board may also set a monthly late fee by resolution.

#### Section 3. Separability

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town Board of the Town of Tusten hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

#### Section 4. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

#### Section 5. Effective Date

This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
