# **MINUTES**

# 1. CALL TO ORDER

Chairman Buckley called the meeting to order at 5:30 PM.

## 2. ROLL CALL

#### 3. ACTION ITEMS

A. Request for a Planned Unit Development (PUD) for a multi-family residential development (3 buildings/45 units total) at 3000 Forest Avenue, submitted by Arik and Lawrence Hansen (property owners) and Edward Fisher (Agent for potential buyer)

Motion to recommend approval and forward to Council for public hearing with the following conditions:

- Any requirements of the engineering, utility, and water department directors.
- Granting a variance for the encroachments into the front setback, to include the patios and decks on Building 1, northeast corner of Building 2, portion of the access/parking area for Building 2 and the northeast corner of the east guest parking stall.
- Landscaping and lighting plans shall be submitted for review by the Plan Commission prior to April 30, 2022.
- Submit plans for all signage for review by the Plan Commission.
- All stormwater management and the public sewer easement issues shall be addressed and reviewed by the Plan Commission.
- Any requirements from the State of Wisconsin.
- All required permits shall be obtained prior to construction.
