Public comments. There were no public comments.

The first item on the agenda was to review and consider minutes from the meeting held March 28, 2022. Councilmember, Russell Machann, made a motion to approve the minutes as presented. Councilmember, Steven Schneider, seconded. All voted in favor.

The second item on the agenda was to review and consider a request from the Wharton County Farmer's Market requesting permission for the placement of portable restrooms for the remainder of the Spring Season, May 14, 2022- June 25, 2022, at Guffey Park. Ms. Kodi Kieler, President of the Wharton County Farmer's Market, stated to the Committee that the Farmer's Market was requesting permission for the placement of portable restrooms for the remainder of the Spring Season, May 14, 2022- June 25, 2022, at Guffey Park. She stated that the Farmer's Market would be asking for one male restroom, one female restroom and one hand-washing station. She stated that the restrooms would be picked up and cleaned weekly and once the restrooms were placed, they would be locked when on the premises of Guffey Park. She stated that the Committee wanted to paint a mural on the exterior bathroom wall facing the entrance to Pleasure Park for this proposed volunteer event. After some discussion, Councilmember, Terry Freese, made a motion to recommend to the City Council to approve the Beautification Commission's request to pursue a Mini Mural Project at Pleasure Park. Councilmember, Steve Schneider, seconded the motion. All voted in favor.
