# MINUTES OF CITY OF WHARTON CITY COUNCIL REGULAR MEETING NOVEMBER 12, 2024

Mayor, Tim Barker declared a Regular Meeting duly open for the transaction of business at 7:00 P.M. at City Hall 120 E. Caney Street Wharton, TX. Councilmember, Russell Machann, led the opening devotion, and Mayor, Tim Barker led the pledge of allegiance.

Councilmembers present were: Mayor, Tim Barker, and Councilmembers, Terry Freese;

#### Roll Call and Excused Absences.

Councilmember, Russell Machann, moved to excuse Councilmember, Larry Pittman. Councilmember, David Voulgaris, seconded the motion. All voted in favor.

#### **Public Comments.**

Mayor, Tim Barker, called for Public Comments. No comments were given.

#### Wharton Moment.

Mayor, Tim Barker, called for Wharton Moments.

- 1. City Manager, Joseph R. Pace, attended a Veteran's Day ceremony at the Veteran's Memorial where Mayor, Tim Barker, presented a proclamation.
- 2. City Manager, Joseph R. Pace, stated the paving work was to be completed within one week at the FM 1301 intersection with Richmond Rd.
- 3. City Manager, Joseph R. Pace, congratulated Police Chief, Terry David Lynch on receiving the Hobby School of Public Affairs Leadership Award.
- 4. Councilmember, Burnell Neal, congratulated the Just Do It Now Football team on advancing to the Superbowl for their league.
- 5. Mayor, Tim Barker, stated the he was impressed by the work that was completed on I-69 from the river bridge to FM 691.

#### **Review and Consider:**

The first item on the agenda was to review and consider the reading of the minutes from the regular meetings held on October 14, 2024, and October 28, 2024. After some discussion, Councilmember, Russell Machann, moved to approve the reading of the minutes from the regular meetings held October 14, 2024, and October 28, 2024. Councilmember, Terry Freese, seconded the motion. All voted in favor.

The second item on the agenda was to review and consider a request from Ms. Kristi Bybee to address the City Council regarding higher water/sewer bills. Ms. Bybee was not in attendance to present her item. After some discussion, no action was taken.

The third item on the agenda was to review and consider a request for disannexation of a 14.76 ac. tract of land, situated in the A. Jackson Timber League, Abstract No. 34, Wharton County, Texas. Planning and Development Director, Gwyn Teves, presented a request for disannexation. Director Teves stated that since the City's Charter was silent on disannexation, the Council could vote on whether to grant the request and pass an ordinance or deny the request. She said the Texas Local Government Code Sec. 43.148 required a City that disannexes an area to refund the owner for property taxes in certain instances such as the amount of money collected by the municipality in property taxes and fees from those landowners during the period that the area was a part of the municipality less the amount of money that the municipality spent for the direct benefit of the area during that period. Director Teves stated the total amount the City would have to refund the property owners was \$1582.41. After some discussion, Councilmember, Russell Machann, moved to approve the request for disannexation of a 14.76 ac. tract of land, situated in the A. Jackson Timber League, Abstract No. 34, Wharton County, Texas. Councilmember, Terry Freese, seconded the motion. All voted in favor.

The fourth item on the agenda was to review and consider an ordinance to disannex certain territory from the corporate limits of the City of Wharton to wit: 14.76 acres in the A. Jackson Timber League, Abstract No. 34, Wharton County, Texas, and as described in the attached Exhibit "A"; finding that all required legal conditions have been satisfied; terminating the rights and privileges conferred on the property from the City of Wharton; providing for amending and correcting the official boundaries of the City of Wharton, Texas, as heretofore adopted; authorizing the City Manager to undertake certain actions relative to said disannexation; providing a severability clause; providing a repealer clause; and providing for said ordinance to take effect and be in force from and after its passage. Planning and Development Director, Gwyn Teves, stated that since the City's Charter was silent on disannexation, the Council could vote on whether to grant the request and pass an ordinance or deny the request. She said that if approved, the disannexation would be effective immediately. After some discussion, Councilmember, Russell Machann, moved to approve City of Wharton Ordinance No. 2024-17, which read as follows:

AN ORDINANCE TO DISANNEX CERTAIN TERRITORY FROM THE CORPORATE LIMITS OF THE CITY OF WHARTON TO WIT: 14.76 ACRES IN THE A. JACKSON TIMBER LEAGUE, ABSTRACT NO. 34, WHARTON COUNTY, TEXAS, AND AS DESCRIBED IN THE ATTACHED EXHIBIT "A"; FINDING THAT ALL REQUIRED LEGAL CONDITIONS HAVE BEEN SATISFIED; TERMINATING THE RIGHTS AND PRIVILEGES CONFERRED ON THE PROPERTY FROM THE CITY OF WHARTON; PROVIDING FOR AMENDING AND CORRECTING THE OFFICIAL BOUNDARIES OF THE CITY OF WHARTON, TEXAS, AS HERETOFORE ADOPTED; AUTHORIZING THE CITY MANAGER TO UNDERTAKE CERTAIN ACTIONS RELATIVE TO SAID DISANNEXATION; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING FOR SAID ORDINANCE TO TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE.

**WHEREAS,** The City of Wharton, Texas ("City") is a home-rule city possessing the full power of local self-government pursuant to Article 11, Section 5 of the Texas Constitution, Section 51.072 of the Texas Local Government Code, and the home Rule Charter for the City of Wharton, Texas; and,

**WHEREAS,** Effective November 12, 2024, the City of Wharton agrees to disannex the 14.76-acre tract described by metes and bounds in the attached Exhibit "A"; and,

**WHEREAS,** Pursuant to the authority granted in Section 43.142 of the Texas Local Government Code, a municipality may disannex an area from the municipality "as may be provided by the charter of the municipality and not inconsistent with the procedural rules prescribed by [Chapter 43 of the Texas Local Government Code]"; and,

**WHEREAS**, Article I, Section 9 of the City of Wharton Charter authorizes the City to fix or adjust its boundaries; and,

**WHEREAS**, The City, pursuant to Chapter 43 of the Texas Local Government Code, as amended, has instituted proceedings to disannex the Property from the City; and,

**WHEREAS**, All statutory notices pursuant to Chapter 43 of the Texas Local Government Code have been published, delivered, or otherwise accomplished.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHARTON, TEXAS, that:

**Section I.** The facts and recitations in the preamble and recitals of this ordinance are found and declared to be true and correct and adopted as part of this ordinance for all purposes.

**Section II.** The property that is the subject of the agreement referenced above and that is described in Exhibit "A", attached to this Ordinance and incorporated herein for all purposes, is hereby disannexed from the corporate limits of the City of Wharton, Wharton County, Texas, and the same is no longer a party of the City.

**Section III.** All rights, privileges, and responsibilities previously conferred on the property described in the attached Exhibit "A" and any citizens and inhabitants of that property are immediately terminated, and are of no force and effect, immediately upon the disannexation of the property from the City of Wharton.

- **Section IV.** The official map and boundaries of the City heretofore adopted and amended are hereby amended to exclude the area described in Exhibit "A" so as to accurately reflect that said area no longer is a part of the City of Wharton, Wharton County, Texas.
- **Section V.** The City Manager is directed and authorized to perform or cause to be performed all acts necessary to effectuate this Ordinance, including but not limited to any corrections to the official map of the City of Wharton so as to accurately reflect the City's boundaries, and to delete the area hereby disannexed as required by law.
- **Section VI.** The City Manager is directed and authorized to file a certified copy of this Ordinance with any and all necessary governmental agencies or entities so affected by the acts described herein, including the United States Department of Justice.
- **Section VII.** It is the intent of the City Council to disannex from the corporate limits of the City of Wharton the entirety of the property described in Exhibit "A" attached hereto, and the City Council hereby finds and determines that the provisions of Chapter 43 of the Texas Local Government Code have been fully complied with in effecting this disannexation. It is not the intent of the City of Wharton to disannex any territory that it has no legal right to disannex; rather, it is the intent of the City Council and the City of Wharton to disannex only such territory as may be legally disannexed by the City within the limits of the described property.
- **Section VIII.** It is hereby declared to be the intention of the City Council that if any word, phrase, clause, sentence, paragraph, or section of this Ordinance is declared to be illegal, invalid, or unconstitutional by the valid judgment or decree of a court of competent jurisdiction, such adjudication shall not affect the application of any remaining word, phrase, clause, sentence, paragraph, or section of this Ordinance. Similarly, the City Council declares this if a court of competent jurisdiction determines that any portion of said properties is incapable of being annexed by the City, the City Council would have adopted the valid portions and applications of this Ordinance and would have annexed the valid property without the invalid part and the invalid properties, and to this end, the provisions of this Ordinance are declared to be severable.
- **Section IX.** Any provision of any prior ordinance of the City, whether codified or uncodified, which is in conflict with any provision of this Ordinance, is hereby repealed to the extent of the conflict, but all other provisions of the ordinances of the City, whether codified or uncodified, which are not in conflict with the provisions of this Ordinance shall remain in full force and effect.
- **Section X.** This Ordinance shall take effect and be in full force immediately from and after its passage as the law in such case provides.

The eighth item on the agenda was to review and consider a resolution of the Wharton City Council approving the roof repairs at Hesed House located at 413 W. Colorado Street and authorizing the Mayor of the City of Wharton to execute all documents related to said repairs. Public Works Director, Roderick Semien, presented a copy of a memorandum regarding the roof repairs at Hesed House located at 413 W. Colorado Street. 

Dear members of Wharton City Council;

We are requesting a onetime waiver of the \$1,275.00 penalty and service charge waiver that the City of Wharton is charging us for cutting the grass on a 3 acres parcel of land that we own at 0 Old Chaney Road, Wharton. Here is the background of this request;

- 1. We have been a longtime good member of the Wharton community having purchased Country Club Apartments, on Old Chaney Road about 30 years ago. For 30 years we have been a good member of Wharton community and a substantial taxpayer. At the same time providing an excellent place to live to the resident of this community, and employment in the city.
- 2. About 7 years back we purchased a 3-acre parcel of land next to Country Club Apartments with the intention of building 50 more apartments units on it. We have been maintaining this property nicely, with its grass cut regularly and properly since it was acquired. We have hired the services of a local contractor to maintain the property in good shape.
- 3. Our contractor cut the grass on the property on September 5, 2024 (please see the attached paid invoice to the vendor). Apparently the city had inspected the property in the month of September (but on or around September 3rd). The City tried contacting us via a letter which unfortunately we did not receive.
- 4. Although the grass was cut by us on September 5, the city decided to cut the grass on 10/04/2024, and billed us a grass cutting charge and penalty totaling \$1,275.00.
- 5. We met with the city to discuss this situation. According to the City, a certified Letter was sent to us. However, the letter was never received by us. The City also has not received the signed receipt acknowledging that the letter was delivered. So they feel that the letter may still be in transit.
- 6. We want to assure the City and the City Council that we will pay better attention to the grass on our land that it is maintained in accordance with the City's code requirements.

At this time, we would like to request the City Council to give us a onetime waiver of this \$1,275.00 charge. We had already cut the grass on our land, unfortunately the letter notifying us of this shortfall never reached us, and finally considering that we have always complied with all of City's requirements and NEVER had any dispute of any sort with the City.

The City of Wharton makes a conscientious effort to ensure the city retains the quality of being a healthy, safe, and aesthetically pleasing place to live. The City of Wharton Code Enforcement Department is responsible for working with citizens and/or businesses to ensure this goal is met. - Action must be completed within ten (10) days from the date of this notice.

### Failure to Comply

- The City will arrange for the property to be moved at the owner's expense.
- Failure to pay the fees due shall result in a lien filed against the property

Please ensure grass clippings, leaves, and weeds are not blown or swept into the street to comply with a new city ordinance, Section 34-46.2, effective March 21, 2024. Be aware that if another violation of this same kind of nature poses a danger to public health and safety during this calendar year; the City, without further notice, will correct the violation at the Owner's expense, assess the expenses against the property, and may result with a complaint filed in Municipal Court.

If you claim not to own the property, you must provide proof that you have transferred ownership, including the new owner's name and last known address to the Code Enforcement Department no later than the 10th day you receive this notice.

# THE STATE OF TEXAS § COUNTY OF WHARTON §

# CONTRACT FOR AMBULANCE TRANSFERS WITNESSETH:

This is a contract and agreement for emergency ambulance transfer of patients between the City of Wharton, Texas, hereinafter referred to as "City", acting through and by its Mayor, and Oak Bend Medical Center, Wharton, Texas, hereinafter referred to as "OBMC," acting through and by its CEO, and the parties mutually agree and contract as follows:

I.

The City agrees to provide ambulance service to out-of-city facilities for patients of OBMC who are hospitalized in the City of Wharton, Texas.

II.

The term of this Amended Contract shall begin December 9, 2024, and shall auto-renew. Termination of this Amended Contract may be accomplished by either party by giving thirty (30) days' written notice to the other party.

The term of this Contract is for two (2) years and shall begin, 2022 and shall end, 2024. The original contract may be extended for additional one-year periods upon written agreement by both parties. Termination of this agreement may be made by either party by giving ninety (90) days written notice to the other party.

III.

The City shall bill OBMC directly and all payments to the City of Wharton shall be due in 30 days. Failure by OBMC to pay will allow the City to charge a late fee of the highest amount allowed by the statutes of the State of Texas. Should OBMC fail to pay the City for 60 consecutive

days, the City at its sole option shall have the right to cancel this agreement on the 61st day of the described delinquency.

### IV.

This agreement is contingent upon the City having an ambulance and crew available. If no ambulance and crew are available, OBMC shall find other ambulance services for their patients. This agreement is intended to be used as a backup ambulance service and not OBMC's primary ambulance service.

#### V.

OBMC (which title is intended to include any and all professional entities and technical persons rendering services under this Agreement), agrees to INDEMNIFY AND HOLD THE CITY, ITS OFFICERS AND EMPLOYEES, HARMLESS, against any and all claims, lawsuits, judgments, costs, liens, losses, expenses, fees (including reasonable attorney's fees and costs of defense), proceedings, actions, demands, causes of action, liability and suits of any kind and nature, including but not limited to, personal injury (including death), property damage, or other harm for which recovery of damages is sought that may ARISE OUT OF OR BE OCCASIONED OR CAUSED BY OBMC'S NEGLIGENT ACT, ERROR, OR OMISSION OF OBMC. The Indemnity provided for in this paragraph shall not apply to any liability resulting from the sole negligence of the City, its officers, or employees, in instances where such negligence causes personal injury, death, or property damage.

The City of Wharton agrees to INDEMNIFY AND HOLD OBMC, ITS OFFICERS, AND EMPLOYEES HARMLESS TO THE EXTENT ALLOWED BY TEXAS LAW GOVERNING PUBLIC ENTITIES.

### VI.

Should the City transport OBMC inpatients to other facilities, the City will bill OBMC for these transfers subject to verification of the services by the City at the current Medicare rates and as amended in the future.

## VII.

The level of care to be rendered to the patient by the City shall be based on the level of service required by the patient.

### VIII.

OBMC shall strive to have all patients ready for transfer when requests for services are made to the City as well as arrange for the reception of transferred patients to other hospitals.

#### IX.

OBMC will not be responsible for services rendered by the City if not billed by the City within one year (1) after the City renders services.

## X.

This contract was executed in the City of Wharton, Wharton County, Texas, and shall be construed under the law of the State of Texas.

# XI.

This contract shall be binding upon and inure to the benefit of the parties hereto, their successors, and assigns.
