City Manager Andres Garza, Jr. declared a meeting of the City Council Public Safety Committee duly open for the transaction of business at 12:08 p.m.

Committee Members present were:	Councilmember Terry Freese and Councilmember Donald Mueller.
Committee Member absent was:	None.

Staff Members present were:	City Manager Andres Garza, Jr., Finance Director Joan Andel, Assistant to City Manager Brandi Jimenez and Police Chief Terry Lynch.

The third item on the agenda was public comments. There were no public comments.

The fourth item on the agenda was the reading of the minutes from the meeting held June 12, 2017. Councilmember Terry Freese made a motion to approve the minutes. Councilmember Don Mueller seconded the motion. All voted in favor.

The fifth item on the agenda was to review and consider rifle buy-back program for the Wharton Police Department. Chief of Police Terry Lynch presented to the Committee the rifle buy-back program. He stated that the proposed program required the City to purchase twenty six (26) rifles upfront and the individual officer will buy the rifle from the City through a payroll deduction over twenty six (26) pay periods. He stated that City Attorney Paul Webb has reviewed and approved the agreement that will be between the City and the individual officer. He stated that four (4) bids were received. After some discussion, Councilmember Terry Freese made a motion to recommend to the City Council the approval of the rifle buy-back program and that the purchase of the rifles be made from Carroll's Gun Shop. Councilmember member Don Mueller seconded. All voted in favor.

The sixth item on the agenda was adjournment. There being no further business to conduct Councilmember Don Mueller moved to adjourn the meeting. Councilmember Terry Freese seconded the motion. All voted in favor.

The meeting adjourned at 12:45 p.m.
