Visitors present were:	City of Wharton Finance Director Joan Andel and City Secretary Paula Favors.

Roll Call and Excused Absences. After some discussion, Boardmember David Voulgaris moved to excuse Boardmember Gary Nunez. Boardmember Curtis Edwards seconded the motion. All voted in favor.

Public Comments. No comments were given.

The first item on the agenda was to review and consider Appointment of Officers. Executive Director Gwyn Teves stated it was time to appoint the officers of the board. After some discussion, Boardmember Worthy Carpenter moved to appoint the following:




