City Manager Andres Garza, Jr. declared a meeting of the City Council Wharton Economic Development Corporation Board of Directors Selection Committee duly open for the transaction of business at 6:00 p.m.

The third item on the agenda was Public Comments. There were no Public Comments.

The fourth item on the agenda was to review and consider the reading of the minutes held September 24, 2018. Councilmember Steven Schneider made a motion to approve the minutes. Councilmember Clifford Jackson seconded the motion. All voted in favor.

The fifth item on the agenda was to review and consider the Appointments-Wharton Economic Development Corporation Board of Directors for the term beginning October 1, 2019 to September 30, 2021. Councilmember Steven Schneider made a motion to adjourn. Committee Member Clifford Jackson seconded the motion. The meeting adjourned at 6:30 p.m.
