RESOLUTION NO. 2024-2

A RESOLUTION ESTABLISHING THE CITY OF WILLOWICK HONORARY STREET NAMING POLICY

WHEREAS, the City of Willowick desires to establish a policy by which citizens may make application to the City to honor an individual or group of individuals that have made significant contributions or impact to the City by permitting the honorary naming of a portion of a City street in their name(s); and

WHEREAS, the Streets, Sewers and Sidewalks subcommittee of Council has recommended the establishment of guidelines/policy to govern applications submitted to the City for the naming of streets in honor of individual or group of individuals; and

WHEREAS, the City finds the policy established by the Streets, Sewers and Sidewalks subcommittee for the honorary naming of portions of City streets to be appropriate and in the best interests of the City and the orderly operation of its administration.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Willowick, County of Lake, and State of Ohio:

<u>Section 1.</u> The City hereby establishes and adopts the Honorary Street Naming Policy set forth on the annexed Exhibit A, which may be amended from time to time by majority vote of the Council of the members of City of Willowick.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 123 of the Codified Ordinances of the City of Willowick.

<u>Section 3</u>. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety by the City and for the further reason that it is necessary to provide for the orderly operation of the City's administration and municipal departments; wherefore this Resolution shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.

City of Willowick Honorary Street Naming Policy

<u>Purpose</u>. The City of Willowick Honorary Street Naming Policy allows citizens or organizations to make application to the City of Willowick to honor an individual or group of individuals that have made significant contributions or impact to the City of Willowick by providing an honorary designation of a portion of a City street in honor of the individual or individuals.

Qualifications of Honoree(s). The honoree(s) must be resident(s) of the City of Willowick that: (a) is deceased or retired from a distinguished career for a minimum of two (2) years, (b) made significant contributions to the community, arts, science, religion, entertainment, philanthropic cause or business, (c) volunteered time and effort for the betterment of the city, state or country, or (d) served with distinction in the United States armed forces or City safety forces.

Street. The honorary naming of a street is permitted for a portion (1 block) of a City street, only. Where an honorary street sign is installed, the original name of the street and postal addresses will remain the same. The honorary sign will be different in color or design and will be added or incorporated into the original street sign. The design will be white lettering on a blue background.

<u>Application for Honorary Street Name Designation</u>: An individual or organization requesting the honorary designation shall submit their application to the Council Member of the Ward in which the sign is to be placed. The Council Member shall submit the application with his/her recommendation or opposition to the City of Willowick Streets, Sewers and Sidewalks Committee.

All applications shall contain the following:

- (1) Name, address and telephone number of the applicant; and
- (2) Name of honoree(s) as it would appear on the sign; and
- (3) Summary of the reason for the request and qualifications of the honoree(s) in accordance with this policy; and
- (4) The address and geographical map clearly marked or highlighted of portion of the City street the application is seeking the honorary designation; and
- (5) Application fee of \$100.00 (to be applied towards the costs of the approved sign; if the sign is not approved, the application fee will be returned to the applicant).
- (6) If the application is for an honorary designation on a residential street, the application shall be accompanied by the consent of at least seventy percent (70%) of the property owners of the street.

<u>Approval</u>. After submission of the application to the Streets, Sewers and Sidewalks committee, the committee shall provide notice to the property owners within the portion of the street to be designation at least fourteen (14) days prior to the meeting at which the application will be considered; those speaking in favor or in opposition to the application may speak at said meeting. Following the meeting, the committee shall submit its recommendation to approve or deny the application to the City Council.

The City Council shall consider the recommendation of the committee, and any other information it deems relevant to the honorary designation, in its legislative approval or denial of the application.

Removal. The City shall bear the costs of production and installation of the sign. The City reserves the right to terminate the program, remove the honorary designation or take possession of the honorary sign for any reason, in the sole discretion of the City Council. The City will bear responsibility for maintenance of honorary signs.

RESOLUTION NO. 2024-4

A RESOLUTION RECOGNIZING AND SUPPORTING FAIR HOUSING, AND DECLARING AND EMERGENCY.

WHEREAS, 2023 marked the 55th Anniversary of the passage of Title VIII of the Civil Rights Act; and

WHEREAS, the effort to create equal housing opportunities for all people is encouraged at every level of government; and

WHEREAS, it is an important goal of our government to eliminate housing discrimination and assure the rights of every citizen to buy, rent, and sell housing, without regard to race, color, sex, religion, familial status, national origin or disability; and

WHEREAS, Title VIII of the Civil Rights Act and Presidential Executive Order 12892 describes the obligation to Affirmatively Further Fair Housing (AFFH); and

WHEREAS, it is a goal of the City of Willowick to accord residents with an enhanced quality of life through the development of opportunities in housing, employment, education and services by the implementation of plans that assure all people are afforded their rights thus fostering open inclusive communities; and

WHEREAS, as an applicant or potential recipient of federal funds, the City of Willowick agrees that it will take specified actions to Affirmatively Further Fair Housing (AFFH) and that the City to the best of its knowledge and belief asserts that that all policies and practices adopted and in place are in conformance with applicable fair housing law and that prior to May 21, 2019 any outstanding civil rights matters are resolved per HUD Docket No. FR-5800-N-0I Section Ill-C.2b ELIGIBILITY INFORMATION-Threshold Requirements; and

NOW, THEREFORE BE IT FURTHER RESOLVED, by the Council of the City of Willowick:

Section 1. The City hereby recognizes the duty to affirmatively support Fair Housing within the City of Willowick.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 123 of the Codified Ordinances of the City of Willowick.

Section 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety by the City and for the further reason that it is necessary to provide for the orderly submission of grants for funding of municipal departments;

Wherefore this Resolution shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.

RESOLUTION NO. 2023-8

A RESOLUTION BY THE WILLOWICK CITY COUNCIL, ADOPTING A POLICY FOR DISTRIBUTION OF GRANT FUNDING FROM THE OHIO AMBULANCE TRANSPORTATION PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, Willowick Fire Department is in receipt of Twenty Thousand Dollars (\$20,000.00) in grant funding from the Ohio Ambulance Transportation Program, which distributes sub awards from the State of Ohio's Coronavirus State Fiscal Recovery Fund as premium pay to eligible fire department employees who provided ground ambulance transport during the COVID-19 pandemic; and

WHEREAS, as a condition of the receipt of the grant funding, the State of Ohio requires a recipient to adopt a policy for distributing the premium pay grant funds.

NOW, THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF WILLOWICK, LAKE COUNTY, OHIO, AS FOLLOWS:

Section 1. The policy set forth below is hereby adopted for the distribution of grant funding from the Ohio Ambulance Transportation Program:

DISTRIBUTION POLICY

- A. In response to the impact of the COVID-19 pandemic on emergency medical workers, Willowick will utilize the grant funding from the Ohio Ambulance Transportation Program to provide premium pay to eligible workers in the Willowick Fire Department in accordance with the U.S. Treasury's Coronavirus State and Local Fiscal Recovery Funds final rule and following all guidelines of the Ohio Ambulance Transportation Program.
- B. Premium payments will be made to eligible workers employed by the Willowick Fire Department from 1-27-2020 to 4-10-2023 and who remain employed at the time of distribution.
- C. Premium payments will be made as a one-time lump sum payment to an eligible worker based upon the eligible worker's total hours worked from 1-27-2020 to 4-10-2023. The hourly rate of pay will be determined by dividing the total amount of funds received from the Ohio Ambulance Transportation Program by the total of all hours worked by eligible workers from 1-27-2020 to 4-10-2023.

<u>Section 2</u>. That this Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willowick and further, provides for the timely acceptance and distribution of grant funds for the operation of a municipal department.

WHEREFORE, this Resolution shall be in full force and effect from and after its passage and approval by the Mayor.
